Scholarship Prep has been active in engaging with our stakeholders to support student learning, safety, and well-being. The major focus of our engagement and community work since March 2020 has been identifying the impact of COVID-19 and determining the best methods to prevent and mitigate student learning loss, anxiety, stress, and physical impact. We engaged with families, students, teachers, staff, and the larger community to gather input directly aligned to the development of this plan. The engagement efforts

coincided with the development of additional LEA plans, including the 2021-2024 LCAP, the Extended Learning Opportunities (ELO) Grant Plan, the 2020-21 School Plan for Student Achievement (SPSA), and internal working documents.

Methods used to solicit input and feedback include Lead Teacher meetings, Teacher and Staff meetings (including gen ed and special education teachers, special education and instructional aides, and other support staff), Coffee with the Principal meetings, Parent Teacher Association meetings, English Learner Advisory Committee meetings, meetings with school Principals and Directors (including the Director of Special Education and the Director of Student Services), Board of Directors meetings, and the annual surveys provided to students, families, and staff. Tribes, civil rights organizations, and individual advocates were not consulted with, however, we do meaningfully consult with other community partners such as student support partners, after school program partners, and authorizer support partners (ie: SELPAS, County Offices of Ed, etc.)

Scholarship Prep leadership met to review the entirety of the quantitative and qualitative data shared by all stakeholders. Three common themes emerged across all groups that were either current concerns or preventative measures moving forward. The three main areas of focus were: behavior supports for students returning to school from virtual learning, supports for our most vulnerable students (students with disabilities, those experiencing homelessness or foster care), and technology integration. Scholarship Prep leadership took those focus areas and identified positions that would ensure stakeholder concerns were addressed. Behavior supports will be addressed through our Dean and Psychologist positions, supports for our most vulnerable students will be addressed through our Student Services Coordinator and special education personnel, and a Lead IT Tech will support technology integration and continued focus on individualized instruction through online software.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

 - Implementing evidence-based activities to meet the comprehensive needs of students,
 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
 - Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;

- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
